



- It is recommended that the title of each course be mentioned before its corresponding content.
- Advised maintaining the proportion of theory (20 marks) and problems (80 marks) in each Commerce syllabus.
- Emphasized the inclusion of recent editions of textbooks and reference materials in the syllabi.
- Suggested that e-learning resources be integrated into the curriculum.
- Requested the Head of Computer Science to add more reference books to certain syllabi.
- The team proposed that the final-year project work be carried out / done in other institutions and industries, and in-campus projects should be specified in the curriculum.
- Dr. R. Sampath Kumar, Managing Director of M/S Kamala Specialty Hospital Pvt. Ltd., Kovilpatti, also commended the faculty members for their efforts in providing quality education to the student community.
- Dr. B. Umadevi, Convener of the CDC, extended her gratitude to all the members, and the meeting concluded at 4:00 p.m., followed by lunch.
