### **Scribe Policy**

G. Venkataswamy Naidu College (Autonomous) – Controller of Examinations Guidelines for use of a Scribe/Paper writer for Visually Handicapped/Orthopedically Handicapped candidates (Whose Writing speed is affected).

A Scribe/Paper Writer, to write the Theory/Laboratory Internal/External Examination, on behalf of Visually Handicapped (VH) candidate (Blind) and Orthopedically Handicapped (OH) Candidate (Whose writing speed is affected), may be used. In all such cases where a Scribe is used, the following rules will apply:

- The candidate will have to arrange his/her own scribe at own cost and inform to the Controller of Examinations.
- The academic qualification of the scribe should be less qualified than the candidate.
- Both the candidate as well as the scribe will have to give a suitable undertaking AS PER FORMAT ATTACHED IN ANNEXURE that the scribe fulfils all the stipulated eligibility criteria.
- In case, it later transpires that the scribe did not fulfil any of the laid down eligibility criteria or had suppressed material facts, the Examination of the candidate will stand cancelled, irrespective of the result of the written examination.
- Candidates who use a scribe will be eligible for extra time @ 30 minutes i.e., total time allowed 3.5 Hours (from 10:00 AM to 01:30 PM in the forenoon session and 02:00 PM to 05:30 PM in the Afternoon Session)

- The candidate is Blind/low vision or physically affected and is with impairment and his/her writing speed is affected and he/she needs a writer (Scribe) as permissible for physically challenged persons.
- The Scribe is identified by the candidate at own cost and is as per own choice.
- The Scribe fulfils the following Criteria: He / She is less qualified (Intermediate/12<sup>th</sup> Standard / PUC) than the candidate.

- We jointly understand that the Scribe shall only record the answer as suggested by the candidate and shall not import his/her knowledge/make any gesture/ sound or movement to indicate correctness or otherwise of any answer option.
- We undertake to comply with the directions of the invigilator at the center and try not to disturb other examinees.
- Any misconduct committed by the Scribe shall amount to a misconduct committed by the eligible candidate who is using the Scribe and is liable for disciplinary action as may be deemed appropriate.
- We hereby declare that all the above statements made by us are true and correct to the best of our knowledge and belief. We also understand that in case it is detected at any stage we do not fulfil the eligibility norms and /or that the information furnished by us is incorrect/false or that we have suppressed any material fact(S), the Examination of the candidate will stand cancelled. Irrespective of the result of the written examination(S). If any of these short comings is/are detected even after the publishing of result, his/her Examination result is liable to be cancelled. In such circumstances, both signatories will be liable to criminal prosecution.
